15 YEARS PROMOTION TERMS AND CONDITIONS

A. Introduction

1. TopFX Global Ltd (hereinafter the “**Company**” or “**TopFX**”) is a company registered under the Laws of Seychelles with registration number 8424819-1 and is licensed with a Securities Dealer License by the Financial Services Authority (“**FSA**”) of Seychelles under the License No: SD037.
2. The 15 Years Promotion (hereinafter the “**Promotion**”) Terms and Conditions (hereinafter the “**Terms & Conditions**” or “**T&Cs**”) are an integral part of the TopFX Terms of Business (available at <https://topfx.com.sc/pdfs/TopFxTerms&Conditions.pdf>) and provisions set forth herein are considered as an Annex of these terms. Capitalized terms used herein without definition shall have the meanings assigned to them in the TopFX Terms of Business.
3. By participating in this Promotion, the Participants acknowledge that they have read and agreed to be bound by these terms as well as to the general terms and conditions that apply to their account.

B. General Provisions

1. Subject to, and without prejudice to, all other Terms of Business, the Promotion is available to TopFX clients who satisfy the eligibility requirements for the Promotion (hereinafter the “**Eligible Clients**”) as these are set out in these Terms and Conditions.
2. The Promotion is available for existing and new clients of TopFX.
3. The Promotion is valid for the period 1st of June 2025 - 31st of December 2025 both days inclusive (“**Promotional Period**”).
4. The Promotion is available only to natural persons who can form legally binding contracts under the laws applicable in their country of residence (hereinafter referred to as the “**Eligible Persons**”). Without limiting the foregoing, participation in the Promotion is not allowed for persons under the age of 18 or otherwise under legal age in their country of residence. **Minors cannot participate in the Promotion.**
5. Subject to Section B.2. above, the Promotion is available to all existing and new clients of TopFX who during the Promotional Period trade at least fifteen (15) standard round turn lots within a calendar month.
6. Subject to Sections B.2 and B.5 above, only clients whose trades have a duration more than five (5) minutes and equal or less than forty-eight (48) hours during the Promotional Period will be eligible to participate in the Promotion. For the purposes hereof, duration is considered the time between opening and closing of a trade.

7. Each participant agrees that by registering for the Promotion expresses his/her free, prior and informed consent for the Company to process any personal data which they provide while registering. The collection and processing of this data are solely for the purpose of administering and managing the Promotion. The Company shall disclose any data about Participants only to the extent stipulated in these T&Cs. Each participant has the right to withdraw his/her consent for processing of personal data at any time. However, such a withdrawal may at the reasonable discretion of the Company result in the disruption, suspension or termination of the Participant's registration for the Promotion.

C. Specific Promotion Terms

1. Eligible Clients who meet the eligibility conditions set in Section B.2 and B.5, as well as all the eligibility and participation requirements set herein, will be able to participate in the Lucky Draws that will take place after the end of each calendar month during the Promotional Period and get the chance to win the prize described in the table below.

* Meaning from the first until the last day of a calendar month.

2. Eligible Clients will be automatically entered into the Promotion provided that they satisfy the criteria described herein. Eligible Clients will have the chance to enter the Promotion during the Promotional Period and participate to the monthly Lucky Draws. The latest date for entering the Promotion is the 31st of December 2025.
3. In total there will be seven (7) Lucky Draws (i.e. one Lucky Draw for each month) and thirty-five (35) winners (i.e. five (5) winners for each Lucky Draw) during the Promotional Period. An Eligible Client can win more than one Lucky Draw provided that he/she satisfies the criteria described herein.
4. The Lucky Draws will run monthly until December 2025.
5. Each Lucky Draw will take place the first business day of each subsequent month. That is the Lucky Draw for June will take place on the first business day of July and so on.
6. The five (5) lucky winners will be chosen via an electronic draw after the end of each calendar month during the Promotional Period.

7. The Lucky Draw winners will be notified by email and/or by telephone as soon as possible after the draw has been conducted regarding the details of their prize within five (5) business days following the end of each calendar month. All reasonable attempts will be made to contact the winners but if this cannot be achieved within 48 hours since the contact is made, the Company reserves the right to withdraw the prize entitlement and award the prize to an alternative winner selected following the same procedure (i.e., Lucky Draw).
8. The prize of USD 500 is non-withdrawable and can be only used for trading purposes. However, any profits generated from trading with the prize can be withdrawn.

D. Reservation of Rights and Disqualifications

1. TopFX reserves the right to cancel and change any of the above Terms and Conditions at its sole discretion.
2. Notwithstanding any other provision of these terms, the Company shall have the sole discretion to determine the applicant's eligibility under these terms, including, without limitation, whether or not the applicant is eligible. The Company has the right not to accept an applicant for any reason as the Company shall determine in its sole discretion.
3. The Company reserves the right, at its sole discretion, to disqualify any individual that misuses or attempts to misuse the Promotion or breaches the present T&Cs and/or any of Business Terms and to cancel all orders and annul all profits of such client. In these circumstances, The Company shall not be liable for any consequences of the Bonus cancellation.
4. If these terms are translated into a language other than English, then the English version shall prevail whether there is any discrepancy or inconsistency.
5. The Company's Management will resolve any dispute or situation not covered by these terms in a fair manner.
6. The Company reserves the right to cancel, modify, or suspend the Promotion at any time and for any reason. In such an event, the Company shall not be held liable for any loss, damage, or inconvenience caused as a result of the Promotion's cancellation. Participants shall have no claims against the Company in the event of cancellation, modification, or suspension of the Promotion.
